



**LACNIC**, the Internet Address Registry for Latin America and the Caribbean, is the organization responsible for allocating and administering IP Addresses and other related resources (Autonomous System Numbers and Reverse Resolution) for the region of Latin America and the Caribbean and is one of the five Regional Internet Registries that exist worldwide.

### Mission

To administrate Internet numbering resources and contribute to the creation of collaboration and cooperation opportunities that will benefit the regional Internet community, committed to:

- ♦The quality of our services.
- ♦Constantly perfecting an impartial, participative and transparent self-regulation model in cooperation with the other regional Internet registries.
- ♦Promoting the participation of all stakeholders in the organization's processes.
- ♦Adopting and promoting technological advancements and standards within the industry.
- ♦Strengthening the relationships with the main Internet stakeholders within the region.
- ♦Developing regional capabilities through training and the dissemination of Internet-related technology.

As part of this mission, **LACNIC** administrates these resources in a responsible manner, guaranteeing equal access for all of the region's Internet operators and the application of community service criteria. **LACNIC**'s main objectives include contributing to the development of the Internet within the region through an active cooperation policy, promoting and defending the interests of the regional Internet community, and contributing to generate conditions that will allow the Internet to become an effective instrument of social inclusion and economic development for all the countries and citizens of Latin America and the Caribbean.

## Policy Development Process

LACNIC's Policy Development Process (PDP) is open, participative and accessible to all interested parties; it allows any individual or organization the opportunity to participate on a level playing field.

Through the free participation of the different stakeholders, LACNIC aspires to ensure that policies respond to regional interests safeguarding the interests of the community as a whole.



## Actions in Support of the Community

One of LACNIC's objectives is to promote the development of Internet and information technologies within the region, as well as to support the training of human resources capable of translating technological advances into concrete benefits for the Latin American community.

With this objective in mind, LACNIC has adopted an active cooperation policy, participating in different research support projects seeking to complement resources and actions among regional and international organizations. This cooperation policy also aims to promote the consolidation of institutional networks that will generate a critical mass capable of sustaining and driving Internet development within the region.

Within this framework, the Regional Fund for Digital Innovation in Latin America and the Caribbean (FRIDA) has been created jointly with other organizations such as the Internet Society (ISOC) and the International Development Research Center (IDRC). This fund annually summons the presentation of Research and Development projects by institutions from the entire region. FRIDA has supported initiatives submitted by organizations from different countries within our region; the subject matter covered by these initiatives range from purely technological matters to issues relating to the human development of different communities and their use for solving social problems.

In preparation for the World Summit on the Information Society, the governments of Latin America and the Caribbean met in Rio de Janeiro in June 2005 at the Information Society Regional Conference and approved a plan of verifiable goals having to do with the development of the Information Society within the region. This plan received the name of eLAC2007 and was later reviewed in February 2008 (eLAC2010).

LACNIC is strongly committed to this plan and, through the activities carried out by the organization, contributes with the governments of the region towards the achievement of a large number of the goals set forth in that plan.

LACNIC is also involved in other cooperation activities such as:

- + Raíces Project: Installation of anycast copies of root servers within the region covered by LACNIC
- Agreements with universities of the region
- Cooperation agreements with other regional organizations: CLARA (Latin American Coordination of Advanced Networks), Ecom-LAC (Latin American and Caribbean e-Commerce Federation), LACTLD (Organization of Latin American and Caribbean ccTLDs), CTU - ARIN (Caribbean Telecommunications Union and American Registry for Internet Numbers).

LACNIC assumes this commitment by developing support and cooperation activities aimed at the regional community, in the belief that it is only through permanent collaboration/ cooperation between the public and private sectors that significant advances will be achieved in the development of the Information Society in Latin America and the Caribbean.

## Participation within the International Community

LACNIC actively participates in regional and global events. Examples of this include participation in ICANN, IETF, and CITEL meetings, and regional meetings such as WALC and NAPLA. This participation aims at fulfilling the goal of contributing to the representation of regional interests before the international community.

LACNIC has been intensely involved in the entire process of the World Summit on the Information Society (WSIS), and also within the new arena created as part of the WSIS resolutions, the Internet Governance Forum (IGF). The IGF is a forum summoned by the United Nations Organization with the aim of creating a meeting place for the different stakeholders to discuss and debate the issues related to Internet governance at world level.

LACNIC is also a member of the Number Resource Organization, ([www.nro.net](http://www.nro.net)), an organization created by the Regional Internet Registries (RIRs) in 2003.

LACNIC is highly committed to its participation in the NRO, thus recognizing this organization's importance in the coordination of the different activities carried out by the Regional Internet Registries.

Since 2004, the NRO is in charge of the role of the Address Supporting Organization (ASO), an ICANN supporting organization devoted to issues related to Internet Numbering Resources.
