1. Welcome

PW welcomed the attendees.

2. Agenda Review

No items were added to the agenda.

3. ASO Review

PW noted that once the upcoming AFRINIC meeting had concluded, the NRO EC would discuss the next steps regarding the ASO Review.

4. RIR Incident Response Coordination

JC noted that he had asked ARIN security staff to consider the proposed RIR Incident Response team. He added that the RIRs should work together on this and the NRO EC would need to decide whether the work should be done formally or informally.

AP noted that the RIPE NCC's CIO had shared details with the ECG representatives and it was under discussion.

OR noted that, for LACNIC, there was an interest to coordinate on this but noted that expectations should be clear. He added that Carlos Martinez had informed him that this subject had been discussed previously but there had been no agreement on it at the time. He believed, however, that some level of coordination across the RIRs was necessary in case of attack or other incidents.

PW reported that discussions at APNIC were also ongoing. He continued that the following action item should remain open and that the NRO EC should discuss this during the December teleconference: ACTION 20181019-4: All to discuss internally whether an Incident Response Team should be set up and report back during the next NRO EC Meeting.

5. CCG Reports

PW gave an overview of the CGs' activities:

a) CCG

- The CCG attended the IGF:
 - Over 100 delegates visited the RIR booth and around 75 people participated in the scratch card game.
 - o The NRO Continuing Cooperation brochure was distributed.
- The NRO website has been completed and is live (see Secretariat's report)
- The redesign work on the NRO PPT template is ongoing.

b) ECG

- Delegated Extended Stats
 - Work is underway on the reporting of the delegated extended stats. This is a RIPE work item, which has been moved to Q1 2019.
 - There is ongoing discussion on how to report transfers and on the detection of overlaps in the transit process.
- RPKI
 - o Discussion on RPKI reporting proposals is ongoing.
 - The validation reconsidered proposal was submitted to the IETF. The consensus in the room was for the RIRs to run the code to see if it worked before asking for a commitment. The ECG will be working with the RIPE NCC product team to run code in its validator and this is planned for Q1 2019.
- ITHI Reporting
 - o The ECG is still working with the RSCG on this and progress is being tracked by the RSCG.
- RDAP Alignment
 - o Discussion on the alignment of RDAP profiles across the RIRs is continuing. The RIRs will run compliance tests and report on findings.

- Emergency back up Registry
 - A first draft was presented to the ECG by Carlos Martinez. The draft noted two phases: FM
 (Frozen Mode) and MR (Maintenance Required). The ECG will discuss this further in the coming
 weeks.

c) RSCG

- There were no updates to the RSCG's work plan this month.
- The RSCG has submitted a proposal to hold an F2F meeting during the ICANN meeting in Kobe, Japan.

d) Secretariat

NRO Website

SG gave an update on the new NRO Website. She noted that the site had been live for several weeks and there had been no issues reported. She added that the redirects were functioning correctly and that a few issues with GDPR/cookie compliance were still under discussion with the RIPE NCC's legal team.
